According to OSHA, "The VPPs promote effective worksite-based safety and health. Approval into VPP is OSHA's official recognition of the outstanding efforts of employers and employees who have achieved exemplary occupational safety and health."

Star Site status is the highest of three programs offered by VPP. According to OSHA, "This certification is designed for exemplary worksites with comprehensive, successful safety and health management systems."

Obtaining VPP recognition required an extensive application process that documented Duro-Last's corporate commitment to worker safety and health.
